The most important topic I want to address, however, is the future of our chapter. As you have probably noticed, there have been appeals for volunteers for our Executive Board in the *Officers Call* for approximately the past year, and there was a special membership meeting last October where the sole topic was our need for additional members on our board. Vacancies in key positions have existed on our board for some time, and we have no succession plan if any of the current working board members step down. A couple individuals have recently expressed interest, but we need more.

On March 24th, along with several other board members, I participated in a video conference with CAPT Frank Michael, USN (Ret), Program Director, and CAPT Erin Stone, USN (Ret), Senior Director, both from MOAA Council and Chapter Affairs. The subject of the meeting was MOAA's Rescue, Revitalization, and Closure Process for chapters experiencing various types of difficulties. We learned that the most common existential problem faced by chapters is the lack of members to volunteer for leadership positions. Frank mentioned that the French Creek Chapter in Meadville, Pennsylvania recently closed for this reason. We are hopeful of avoiding a similar fate, but without additional help, this remains a distinct possibility.

As has been mentioned previously, the workload for our Executive Board members does not need to be great, and the responsibilities of a position could be tailored to one's availability and preferences. It is also possible for several members to share a single position to further reduce one's time commitment. Since we are fast approaching our decision point, if anyone is interested in

joining our board, please get in touch with me (contact information at the end of this newsletter) if you wish to discuss possible roles and responsibilities.

We will be working with Frank and Erin in the weeks ahead to schedule a chapter rescue event (probably in the June or July timeframe) to which all current chapter members and all MOAA members in our area who are not chapter members will be invited. Several MOAA staff members will participate in this event, and MOAA will also help defray the costs (refreshments and food will be provided). Stay tuned for the details concerning this event. If key vacancies continue to exit after this meeting, it will be time for the Executive Board to decide if the chapter can continue to function.

THE NEW AIR FORCE KC-46 REFUELING TANKER-JOHN HILL of Boeing

The KC-46 provides refueling support to all the services for a multitude of aircraft giving our military global reach. We're fortunate to have Mr. John Hill, of Boeing Company in the local Dayton Office, speak to us on this invaluable program. John Hill served as the USAF KC-46 Chief Engineer, responsible for all technical engineering efforts for development, production, modification and sustainment of the KC-46 fleet, before retiring from the Air Force. Now with the local Boeing office, John is a Customer Engagement Liaison for many USAF programs.

We'll meet at the "Wandering Griffin Brewery & Restaurant," at 3725 Presidential Drive, Beavercreek, near the Home Depot. FINAL PHASE OUT OF WIDOW'S TAX

THE WIDOW'S TAX has finally been repealed in full. The last deduction was taken from our DOD Survivor Benefit Plan (SBP) that has been augmenting the Veterans Administration Dependency and Indemnity Compensation (DIC) for many years. Back in 2021 the US Congress voted to correct this misdeed, but it was phased in over 3 years. Surviving Spouses who qualify for SBP, got their full SBP pay as of February 1, 2023.

Many thanks to MOAA (National) for continuing to meet with Congress for years to push for the repeal of the unjust Widow's Tax. SBP, is an insurance policy that military members who opt into the program, pay for over many years, to provide a survivor benefit to their family when they pass away (on duty or after retirement.). DIC is a Veteran Administration benefit paid upon the death of a military member who died of one of a specific list of qualifying diseases.

CONGRATULATIONS TO MOAA and all of you who took the time to make calls and write letters to Congress, supporting the plight of surviving spouses to finally get what their spouses earned, and to finally have it restored. We all thank you very much.

TRICARE PHARMACY CUTS:

The April 2023 MOAA Magazine, "Military Officer," contains a brief article "When Cuts Hit Home," by CMDR (USN-RET) Roy Kiefer. The article summarizes the challenges to veterans regarding the 2022 announcement that 15,000 pharmacies are dropped from TRICARE network because of contract renegotiations. The result has been that service members, retirees and families are being forced away from their neighborhood pharmacies. This is not acceptable. MOAA and 21 other veteran service organizations in the Military Coalition sent letter to Defense Health Agency calling for a solution. The MOAA magazine contains two formatted letters addressed to the Senate Majority Leader, Charles Schumer, and Minority Leader, Mitch McConnell. We recommend that you send these letters to your Senate leaders for action. The formatted letter focuses on Restoring Basic Allowance for Housing to 100% for service members and reversing the TRICARE pharmacy cuts. Also, MOAA National will be on the Hill on 26 April to seek solutions to these two matters.
