Mr. Koogler was the founder of the Koogler-Suburban Refuse Removal Company and general manager and regional vice-president of Waste Management. After his invaluable experiences and success in the business world, he was elected to become a Greene County Commissioner in 2013. Tom was the recipient of numerous awards and honors including the Governor's Award for leadership and

promotion of the recycling programs in Miami Valley.

DAC BOARD APPROVED OPERATING BUDGET:

As we close out 2022, we consider our Dayton Area Chapter (DC) to be very fortunate as we have been able to provide over \$6,160 to our worthwhile donations. These donations include our High School Scholarship Fund, Marine's Toys for Tots Foundation, Fisher Nightingale Houses, The USO, Honor Flight, and the United States Air Force Museum Foundation. These significant contributions are a result of the dedication and continued support of our chapter membership. Thank you so very much for your continued support to never stop serving our nation and our military services. We will close out 2022 with Total Assets of approximately \$19,010 based on our checking account, Savings, and two Certificates of Deposit. Our Total Liabilities based on dues, and planned 2023 donations are approximately \$5650. Our end of the year 2022 net worth is approximately \$13,360.00. This should allow us to continue our strong support in 2023 to our primary donations as noted above.

We now turn our attention to our 2023 Operating budget which has been tentatively approved by our Executive Board of Directors at our 14 Dec 2022 meeting. Our estimated and planned Operating expenses are \$5,280. Our planned discretionary expenses which include our primary donations are \$6,230 resulting in total 2023 Budget Expenses of ~\$11,510.00. Our estimated Income to support these efforts is forecast at \$10,300. The income contributors are membership dues (~\$2000), USAA donation for the USO fund (\$300), direct member specified donations (~\$3,000), our annual Golf Outing (~\$1,000)supporting USO donation, our member program 50-50 raffles (~\$180) and our dividends from our Credit Union accounts (~\$183) which totals ~\$6,660. You can see that our

ability to continue our worthwhile causes is due to maintaining our strong membership base and the generosity of our members to give back through specific donations. TRICARE SPECIALTY DRUG CHANGES STARTING 1 JANUARY

TRICARE beneficiaries filling specialty medication prescriptions at retail pharmacies should begin moving those prescriptions to <u>Accredo</u>, which will be the primary in-network pharmacy option for specialty medications as of Jan. 1, 2023.

The TRICARE Home Delivery Program and military treatment facility (MTF) pharmacies will continue to be available for some specialty medications, but Accredo will be the only retail specialty pharmacy option for most specialty prescription drugs, which are used to treat chronic, complex conditions such as cancer, rheumatoid arthritis, multiple sclerosis, and hepatitis C..

Only 1% to 2% of TRICARE beneficiaries take specialty medications. Impacted beneficiaries should have received a letter from Express Scripts notifying them of this change. You can also check the <u>specialty drug list</u> on the TRICARE website to verify if any of your medications are specialty drugs.

To fill your specialty medications at Accredo, call 1-877-882-3324 and an Accredo patient care advocate will work with you and your doctor. Accredo provides 24/7 access to personalized care and support from specialty-trained pharmacists and nurses. Your medication also may be eligible for home delivery from Express Scripts; call 1-877-363-1433 to find out. You also can check with your local MTF pharmacy to see whether it stocks your specialty medication on their formulary. If you are receiving your specialty drug through home delivery or an MTF pharmacy, you don't need to make any changes.

Specialty drugs represent a significant and growing portion of <u>TRICARE pharmacy spending</u>. From FY 2018 to FY 2021, TRICARE specialty drug spending increased 43% from \$2.360 billion to \$3.369 billion. In FY 2021, specialty drugs accounted for less than 1% of military health system (MHS) prescription drug utilization, but 47% of MHS drug spending.

Although the cost of specialty drugs is high, some represent significant advances in therapy. The high price may be offset by decreases in future medical costs.

The <u>current TRICARE</u> specialty <u>drug retail network</u> is already very narrow and includes Accredo, Kroger, Rite Aid, and Walgreens. Consolidating TRICARE retail specialty drug dispensing at Accredo will reduce TRICARE's growing pharmacy spending by allowing DoD to leverage the <u>National Prime</u> <u>Vendor procurement/replenishment model</u>, which provides discounted pricing on specialty drugs.
